I was co-chair, along with Felicia Cohn, of the Program Committee for the 7th Annual Meeting of the American Society of Bioethics and Humanities in Fall of 2004.
- 3. Director, Clinical Consultation Program, Center for Health Care Ethics. Duties involved clinical ethics consultation at Saint Louis University and occasional consultation for other client hospitals. I was a member of the Hospital Ethics Committee at Saint Louis University Hospital. I also coordinated on-site clinical ethics activities for students in the Ph.D. Program in Health Care Ethics.
- 4. Medical Students' Ethics Education, Saint Louis University School of Medicine. I directed the ethics unit of the Patient, Physician and Society course since 1998 (with the exception of 2001-20002).
