Saint Louis University and YouGov surveyed 931 likely Missouri voters from September 24 – October 7 about the 2020 Election, current political issues, the COVID-19 pandemic, and education policy in Missouri. The following pages present results for each survey question. The margin of error for survey results for the full sample is 3.9%. Margins of error for questions asked to subsamples are listed below. #### Funding and Support

The origins of the SLU/YouGov Poll lie in an internal Big Ideas competition to define universitywide strategic research priorities sponsored by the Saint Louis University Research Institute. The Big Ideas competition provides funding to research initiatives that demonstrate broad faculty engagement, strong leadership and compelling research plans.

#### Methodology and Weighting

YouGov interviewed 1,063 respondents with an oversample of African-American respondents who were then matched down to a sample of 931 likely voters to produce the final dataset. The full set of survey starts were matched to a sampling frame on gender, age, race, and education. The frame was constructed by stratified sampling from the Missouri registered voter portion of the 2018 Current Population Study voter supplement with selection within strata by weighted sampling with replacements.

The matched cases were weighted to the sampling frame using propensity scores. The matched cases and the frame were combined and a logistic regression was estimated for inclusion in the frame. The propensity score function included age, gender, race/ethnicity, and years of education. The propensity scores were grouped into deciles of the estimated propensity score in the frame and post-stratified according to these deciles.

The weights were then post-stratified on 2016 Presidential vote choice, and a two-way stratification of gender and age (4-categories) from the Missouri voter file to produce the final weight.
